3. Hazard identification

Emergency overview

WARNING: MAY CAUSE EYE, SKIN AND RESPIRATORY TRACT IRRITATION. Ingestion may cause irritation to mucous membranes. Avoid contact with the skin, eyes and clothing. Wash thoroughly after handling. Keep container tightly closed.

Potential health effects

Primary routes of exposure

Routes of entry for solids and liquids include eye and skin contact, ingestion and inhalation. Routes of entry for gases include inhalation and eye contact. Skin contact may be a route of entry for liquified gases.

4. First-aid measures

General advice:

First aid personnel should pay attention to their own safety. Remove contaminated clothing.

If inhaled:

If difficulties occur after vapour/aerosol has been inhaled, remove to fresh air and seek medical attention.

If on skin

After contact with skin, wash immediately with plenty of water and soap. Under no circumstances should organic solvent be used. If irritation develops, seek medical attention.

If in eyes:

In case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

If swallowed

Rinse mouth immediately and then drink plenty of water, seek medical attention. Do not induce vomiting unless told to by a poison control center or doctor.

5. Fire-fighting measures

Suitable extinguishing media:

Hazards during fire-fighting:

Further information:

Product itself is non-combustible; fire extinguishing method of surrounding areas must be considered. The degree of risk is governed by the burning substance and the fire conditions. Contaminated extinguishing water must be disposed of in accordance with official regulations.

6. Accidental release measures

Personal precautions:

Use personal protective clothing. Do not breathe vapour/aerosol/spray mists. Sources of ignition should be kept well clear. Handle in accordance with good building materials hygiene and safety practice.

Environmental precautions:

Contain contaminated water/firefighting water. Do not discharge into drains/surface waters/groundwater.

Cleanup:

For small amounts: Pick up with inert absorbent material (e.g. sand, earth etc.). Dispose of contaminated material as prescribed.

For large amounts: Pump off product.

Handling

Storage

General advice:

Keep only in the original container in a cool, dry, well-ventilated place away from ignition sources, heat or flame. Protect from direct sunlight. Store protected against freezing.

Temperature tolerance

Protect from temperatures below: 32 °F

The packed product must be protected from temperatures below the indicated one.
